

AF Detection Evaluation Plan

Objectives:

- 1. Understand the impact of the project on AF detection.
- 2. Understand the experience for practices and PCNs, including adoption of the pathway for AF detection and management.
- 3. Assess what is working well in delivery, for whom is it working well, and why?
- 4. Understand what challenges and learning from delivery there have been.
- 5. Understand patients' experiences of the AF pathway.





AF Detection Evaluation Plan

Data collection methods:

- Project monitoring sheet recording data at all sites.
- Online survey for HCPs.
- HCP focus group.
- Short patient interviews separately with 6-7 patients.





AF Detection Evaluation Plan

Proposed timeframe:

<u>Task</u> :	<u>Timeframe</u> :
Sites input data onto monitoring form (Ardens template or excel spreadsheet provided).	September to December 2024.
Sites return their completed monitoring data to Sophie.	Early January 2025.
HCP online survey circulated to HCPs in early January 2025.	Deadline for completion of survey: 31 January 2025.
HCP focus group.	Early-mid February 2025.
Patient interviews.	Early-mid February 2025.
Evaluation report drafted.	By end of February 2025.
